GAS EVENT SURCHARGE

Applicability:

This rate schedule is applicable to all firm and interruptible gas sales service rate schedules in Minnesota for the recovery of extraordinary gas costs authorized by the Minnesota Public Utilities Commission in Docket Nos. G999/CI-21-135 and G004/M-21-235 as related to the February 2021 gas event.

Gas Event Surcharge Rate:

The Gas Event Surcharge rates shall be adjusted in accordance with the schedule below. The surcharge will be applicable to all consumption billed under the Company’s firm and interruptible gas sales service rate schedules during the Commission authorized surcharge period. The Gas Event Surcharge rate shall be separately identified on customers’ bills.

The costs and revenues accounted for through the Gas Event Surcharge shall be excluded from the Company’s annual GCR outlined in the Company’s Purchase Gas Adjustment Clause (PGA) rate schedule Sheet Nos. 5-62 and 5-63 except for any over or under recovered amounts remaining at the end of the Commission authorized surcharge period. Any over or under recovered amount remaining shall be included in the Company’s next GCR.

Gas Event Surcharge Discount:

Residential customers who received Low Income Energy Assistance Program (LIHEAP) assistance during the 2019-2020, 2020-2021, 2021-2022, and 2022-2023 heating seasons or with past due balances greater than 60 days but less than 120 days as of June 30, 2021 shall be 100% exempt from the Gas Event Surcharge. Exemptions shall be recalibrated
