- To qualify the certification must be for a **Minnesota** commercial building and must use natural gas from Great Plains Natural Gas Co. as the primary heating source.
  - To qualify for **Energy Star** building rebate you must attach a copy of the completed certification application and an invoice for the professional engineering services.
  - To qualify for the **LEED** building rebate you must attach a copy of the completed certification application, copy of final ratings report, and an invoice for the professional engineering services.
  - To qualify for the **Green Globes** building rebate you must attach a copy of the completed certification application, copy of final ratings report, and an invoice for the professional engineering services.
  - To qualify for the **SB 2030** rebate, contact Great Plains before building design begins.
  - The rebate application form must be postmarked by December 31 of the plan year for the rebate to be processed.

Great Plains CIP rebate programs may be cancelled or changed at any time. Rebate amounts will be issued for projects completed between January 1 and December 31 of the plan year only. Great Plains issues rebates in the form of checks, not utility bill credits. Allow 4-6 weeks for rebate processing.
