

Great Plains Natural Gas residential customers in Minnesota are eligible to have an energy assessment performed on their home for a cost of \$50.

A home energy assessment gives you a thorough picture of where your home is losing energy and how you can save money.

Here is how the program works:

Fill out the application and send it to Great Plains. If you are approved for an energy assessment, Great Plains will notify you, and a third-party contractor will contact you to schedule the audit. Once the audit is complete, Great Plains will bill you \$50 for the assessment. Typically a home energy assessment can cost up to \$500. Great Plains has a limited number of residential energy

assessments available to its natural gas customers, and assessments are approved in the order in which they are received.
