Programmable Setback Thermostat* Rebate

*The Tier 1 programmable setback thermostat must be purchased and installed along with a new high-efficiency natural gas furnace or boiler. Tier 2 and Tier 3 Wi-Fi connected thermostats do not require contractor installation, nor the purchase of a qualifying new high-efficiency natural gas furnace or boiler. Rebate level for the programmable setback thermostat will be determined at the sole discretion of Great Plains.

Water Heating Rebate

Free Low-Flow Shower Heads: Great Plains customers who heat their water with natural gas are eligible for a free low-flow shower head for each shower fixture in their home.

Furnace/Boiler Tuneup: Great Plains customers are eligible for a rebate of \$50 when they have a furnace or boiler tuneup performed by a qualified contractor. This program is available to customers who have not received a furnace/boiler tuneup rebate from Great Plains in the past two years.

Rebate

Attic Insulation: This program requires that the home have an energy assessment performed (by Great Plains) prior to the insulation project.

The beginning R-Value of the existing attic insulation must be less than R-25 and the ending R-Value of the attic insulation must be R-49 or greater. If the insulation project meets these qualifications, and an energy assessment was performed by Great Plains prior to the project, Great Plains will provide a rebate of \$150 or 50% of the cost of the insulation project, whichever is less.

Home Energy Assessment: Customers are eligible to have a home energy assessment performed on their home for a cost of \$50.

Pilotless Fireplace: Great Plains natural gas customers who purchase and install a new pilotless natural gas fireplace, or retrofit their existing natural gas fireplace, qualify for a rebate of \$75.

The qualifying equipment must be installed in a Minnesota residence serviced with natural gas from Great Plains. Rebate funds are limited and rebates will be processed in the order in which they are received.
