## Heating

## Programmable Setback Thermostat\* Rebate

| Wi-Fi Connected – Tier 2                    | 50   |
| Wi-Fi Connected Learning – Tier 3           | 75   |

\*The Tier 1 programmable setback thermostat must be purchased and installed along with a new high-efficiency natural gas furnace or boiler. Tier 2 and Tier 3 Wi-Fi connected thermostats do not require contractor installation, nor the purchase of a qualifying new high-efficiency natural gas furnace or boiler. Rebate level for the programmable setback thermostat will be determined at the sole discretion of Great Plains.

## Water Heating

**Free Low-Flow Showerheads:** Great Plains customers who heat their water with natural gas are eligible for a free low-flow showerhead for each shower fixture in their home.

**Furnace/Boiler Tuneup:** Great Plains customers are eligible for a rebate of \$50 when they have a furnace or boiler tuneup performed by a qualified contractor. This program is available to customers who have not received a furnace/boiler tuneup rebate from Great Plains in the past two years.

**Attic Insulation:** This program requires that the home have an energy assessment performed (by Great Plains) prior to the insulation project.

Insulation projects that meet the qualifications of the program are eligible for a rebate of 50% of the project cost with a maximum of \$150.

**Home Energy Assessment:** Customers are eligible to have a home energy assessment performed on their home for a cost of \$50.

**Pilotless Fireplace:** Great Plains natural gas customers who purchase and install a new pilotless natural gas fireplace, or retrofit their existing natural gas fireplace, qualify for a rebate of \$75.

**Income Qualified Programs:** Great Plains has heating and water heating programs available to income qualified customers and income qualified multi-family building owners.

### Program Terms & Conditions:

The qualifying equipment must be installed in a Minnesota residence serviced with natural gas from Great Plains. Rebate funds are limited and rebates will be processed in the order in which they are received.
