## Would you like to manage your monthly gas bills and pay past-due balances?

Great Plains Natural Gas Co. offers its Minnesota customers a Gas Affordability Program (GAP) that helps qualified customers manage their monthly gas heating bills and pay past-due balances.

To qualify for the program, you must have received a Low Income Home Energy Assistance Program (LIHEAP) grant for the current heating season. To apply for LIHEAP, please see the contact information listed in this brochure.

### GAP offers qualifying customers two types of credit:

- 1) Monthly Affordability Credit for current natural gas charges:** Your monthly natural gas charges will be averaged for the year. You will receive a monthly credit so your annual gas bill will not be more than 4 percent of your household income.
- 2) Matching GAP Installment Credit for past-due natural gas charges:** Great Plains will set up a GAP Installment Plan to help you pay off your past-due bill over a period of up to 24 months. Each month you pay your GAP Installment amount, a matching GAP credit will be applied to your account. If you make your payment each month, you will be paying for only one-half of your past-due balance.
