Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. Great Plains CIP rebate programs may be cancelled or changed at any time. Rebate amounts will be issued for service received between January 1 and December 31 of the plan year only. Great Plains issues rebates in the form of a check, not utility bill credits. Allow 4-6 weeks for rebate processing. The rebate application form must be submitted within 90 days of the service date or postmarked by December 31 of the plan year, whichever comes first. Great Plains will not issue rebates for more than 100% of the service.
